Calls and text messages with roaming

Prices apply to incoming and outgoing calls and messages while roaming.

Zone 1 – Incoming calls are charged per second. Outgoing calls have an initial billing period of 30 seconds, followed by per-second billing.

Zones 2–3 – Both incoming and outgoing calls have an initial billing period of 60 seconds, followed by 60-second increments.

Outgoing calls outside the EU are always charged at the rate of the higher zone (e.g., if a customer calls from Zone 2 to Zone 3, the call is charged at Zone 3 rates).

If a **national service package** (e.g., voice or data) is purchased, **free minutes, SMS, or data** from the package can be used within the **EU roaming zone**, with an additional roaming surcharge as per this price list.
